No. BTC/Edn(El)-4/2017/292, Dated Kokrajhar the 6<sup>th</sup> June, 2017 and as per power conferred in the Sub-section (2) of the Section (4) of the "Assam Non-Government Educational Institution (Regulation & Management) Act, 2006 and Rule 3 of the Rules, 2007 and RTE Act,2009 in the "Assam Non-Government Educational Institution (Regulation & Management) Rules, 2007" and RTE Act,2009 Prior Permission/NOC is hereby accorded to Bodoland Public School (Ele.) Vill. & P.O.- Gossaigaon, Dist- Kokrajhar, BTC, Assam, with immediate effect from 1-1-2017 subject to the following terms and conditions:-

- 1. The order for prior permission shall be valid for 2 years only within which the applicant shall have to complete the construction works on its own land and run the school as proposed.
- 2. The School/ Jr. College authority shall constitute the Managing Committee as section 12 of the Act.
- 3. The school authority shall have to fulfill all requirements as required under section 10 for the Act and Rule 7, 8, 9, 10, 11, 12, 13 & 14 of the Rules.
- 4. The School / Junior College authority shall prepare a Scheme of Management as required under section 14 of the Act and Rule 16 of the Rules.
- 5. The School authority shall apply for Provisional Registration of the School in Form-11 within a period of 2 years along with copies of all documents.
- 6. In case of failure to complete the task within the specified period of 2 years, this order shall stand cancelled.
- 7. The Term and Condition laid down in the Assam Non Government Educational Institution (Regulation & Management) Act, 2006 and Rule, 2007 and RTE Act, 2009 is to be followed.
