Perused representation submitted by C RICHARD KRWSING, HT /HM, BODOLAND PUBLIC SCHOOL (PVT), Kokrajhar District and all the connected papers concerned with the matter of the representation.

In the representation submitted by the petitioner, C RICHARD KRWSING, it is stated that the school, viz. BODOLAND PUBLIC SCHOOL (PVT) (Annexure-A Sl. No.872) was established on /in the year 17.10.2016 and is presently functioning under the BEEO, GOSSAIGAON, Block, Kokrajhar district and applied for renewal of RTE Recognition for next term of period.

In this regard, as per terms of reference of District Level Redressal Committee (DLRC) re-constituted vide BTC notification No.BTC /Edn (E1)-67 /2021 /44 dtd. 20-04-2022, the DEEO, Kokrajhar cum Member Secretary, DLRC has requested Circle Officer and BEEO concerned to enquire into and submit joint enquiry report in prescribed format as per norms for schools as laid down in the RTE Act, 2009 with photograph of school. Now the officers have submitted the joint enquiry report which is placed before the District Level Redressal Committee (DLRC) and is discussed in the DLRC meeting dated 15.07.2022 for further consideration & recommendation. However, the school previously had RTE recognition & also has running UDISE code and hence the matter is only pertaining to the renewal of grant of RTE recognition under State RTE Rules, 2011.

After detail scrutiny, the school viz. BODOLAND PUBLIC SCHOOL (PVT) is considered for renewal of grant of **RTE recognition** under State RTE rules as recommended by the District Level Redressal Committee (DLRC) on the ground stated in the recommendation as quoted hereunder—

“Recommended for Renewal of Grant of RTE Recognition under State RTE Rules. Availability of running UDISE code, Pucca school buildings in good condition, Ramp & Raill, HM Room, DW facility, Toilet, Playground, Boundary Wall, TLE, Library, Play materials, qualified teachers, enrolment & leased land and previously having Grant of RTE Recognition under State RTE Rules.”

With the above order the representation of the petitioner stands disposed off accordingly.

Sub: Recognition Certificate for the School under sub-rule (4) of rule 11 of Right of Children to Free and Compulsory Education Rules, 2009 for the purpose of Section 18 of Right of Children to Free and Compulsory Education Act, 2009.

Dear Sir /Madam,

With reference to your application dated **11.04.2022**, subsequent correspondence with the school/ inspection in this regard and as per Speaking Order issued by the Deputy Commissioner, Kokrajhar vide No.KOK /SSA /MIS /DLRC /04 /2021 /300 dtd. 16.08.2022, I convey the grant for provisional recognition to **BODOLAND PUBLIC SCHOOL (PVT), GOSSAIGAON - II (Anx-A Sl. No.872)** under **GOSSAIGAON** block for **Class 1 to Class 8** for a period of three years w.e.f. **26.08.2022 to 25.08.2025** under sub-rule (4) of rule 11 of Right of Children to Free and Compulsory Education Rules, 2009 for the purpose of Section 18 of Right of Children to Free and Compulsory Education Act, 2009.

The above sanction is subject to fulfilment of following conditions—


- 1) The grant for recognition is not extendable and does not in any way imply any obligation to recognize /affiliate beyond Class VIII.
- 2) The school shall abide by the provisions of Right of children to Free and compulsory Education Act' 2009 (Annexure I) and the Right of Children to Free and Compulsory Education Rules' 2010 (Annexure II).
- 3) The school shall admit in **class-I** (if exist), to the extent of **25%** of the strength of that class, children belonging to weaker section and disadvantaged group in the neighbourhood and provide free and compulsory elementary education till its completion. Provided, further that in case of pre primary classes also, this norm shall be followed.
- 4) For the children referred to in paragraph 3, the school shall be reimbursed as per section 12 (2) of the Act. To receive such reimbursements school shall provide a separate bank account.
- 5) The Society /School shall not collect any capitation fee and subject the child or his or her parents or guardians to any screening procedure.
- 6) The school shall not deny admission to any child for lack of age proof. If such admission is sought subsequent to the extended provided prescribed for admission. On the ground of religion, caste or race, place of birth or any of them under Rule 21.
- 7) The School shall ensure:
 - a. No child admitted shall be held back in any class or expelled from school till the completion of elementary education in a school.
 - b. No child shall be subjected to physical punishment or mental harassment;
 - c. No child is required to pass any board examination till the completion of elementary education;

- d. Every child completing elementary education shall be awarded a certificate as laid down under Rule 23;
- e. Inclusion of Students with disabilities /special needs as per provision of the Act.
- f. The teachers are recruited with minimum qualifications as laid under section 23 (1) of the Act. Provided further that the current teachers who, at the commencement of this Act do not possess minimum qualifications shall acquire such minimum qualifications within a period of 5 years;
- g. The teacher performs its duties specified under section 24 (1) of the Act and
- h. The teacher shall not engage himself or herself for private teaching activities.
- 8) The School shall follow the syllabus on the basis of curriculum laid down by appropriate authority.
- 9) The school shall enrol students proportionate to the facilities available in the school as prescribed in the section 19 of the Act.
- 10) The School shall maintain the standards and norms of the school as specified in section 19 of the Act. The facilities reported at the time of last inspection are as given under:-

- 11) No unrecognized classes shall run within the premises of the school or outside in the same name of school.
- 12) The school buildings or other structures or the grounds are used only for the purposes education and skill development'
- 13) The School is run by a society registered under the Societies Registration Act.1860 (21 of 1860), or a public trust constituted under any law for the time being in force;
- 14) The accounts should be audited and certified by a Chartered Accountant and proper accounts statements should be prepared as per rules. A copy each of the Statements of Accounts should be sent to the DEO every year.
- 15) The recognition Code Number allotted to your school is **0080 /18**. This may please be noted and quoted for any correspondence with this office.
- 16) The school furnishes such reports and information as may be required by the Director of Education/ District Education Officer from time to time and complies with such instructions of the State Government/ Local Authority as may be issued to secure the continued fulfilment of the condition of recognition or the removal of deficiencies in working of the school.
- 17) Renewal of Registration of Society, if any, be ensured.
- 18) Other conditions as per Annexure 'III' enclosed.
